As you are aware, the Ministry of AYUSH has taken up the preparation for the celebration of 2nd International Day of Yoga on 21st June, 2016. This Ministry has decided to take forward the momentum created by International Day of Yoga 2015 with greater and more active participation of youth during the current year celebrations.

2. In this regard the Inter-Ministerial Committee meeting held on 8/2/2016 under the Chairmanship of MOSHC had inter-alia emphasised the role of Ministry of HRD in involving School/College students in various activities as part of the IDY 2016 celebrations.
