HSS 1st Year and TDC 1st year during the session 2016-17.


Sir/Madam,

In this regard, I would like to inform you that in case of an urgent need of the fund for smooth functioning of the Colleges, all the Principals of the Govt. & Provincialised Colleges are allowed to utilize the required fund, out of the 70% of tuition fees of the students admitted in HS 2nd year and TDC 2nd & 3rd year during the session 2016-17 which is to be deposited to the Govt. Account till the Govt. subsidy for HS 1st year and TDC 1st year released to them.

This arrangement has been made in pursuance to the discussion held with the Principal Secretary to the Govt. of Assam, Education Higher Department on 28/09/2016 in his office chamber.


