Greetings from the Krishna Kanta Handiqui State Open University.

You are aware that the Krishna Kanta Handiqui State Open University, established by an Act of the Assam Legislative Assembly, has been offering various degree programmes, Bachelor's, Master's, Doctoral besides some Diploma/Certificate Courses, under Open Distance Learning System. In order to reach the learners living in various parts of the State, the University, gives recognition to affiliated Degree Colleges, Junior Colleges and Institutions of repute offering degree level programmes in every district of Assam to act as Study Centres of the University. At present we have 337 number Study Centres across the State with enrolment of 1,20,000 learners. It may be pertinent to mention here that almost 90% Study Centres are located in the Affiliated Colleges, the Coordinator of which is appointed from the teachers of the concerned colleges with the approval of the University. Although, we are conducting various courses through our Study Centres smoothly, we need specific instructions on the following matters from your esteemed office to all the Principals of the concerned affiliated Colleges, considering this University being a State University, who is trying hard to extend education to the underprivileged section of the society and to the needy learners who could not reach higher education owing to various reasons:

- 1) As we do not have adequate number of teachers, we have to solely depend on the teachers of the affiliated colleges for conducting our examinations smoothly. When approached, the Principal of Affiliated Colleges is often found to be reluctant to release the teachers on the plea that they do have any guidelines from the government. Therefore, the Principal of affiliated Colleges may be instructed to cooperate with the University and release the teachers as may be required for appointment of Supervising Officers and assigning other duties like, Examining the Answer Scripts, Question Paper settings, invigilation duty etc.etc.,
