

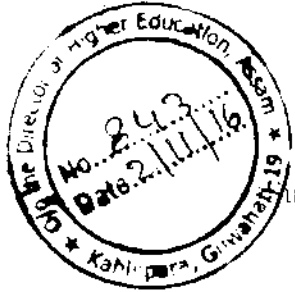

Sir,

I am directed to refer to the subject quoted above and say that the Ministry of HRD, Govt. of India has time and again pressing hard to seed Aadhar number with Bank Account of students for Direct Benefit Transfer (DBT) of various scholarships.

As provision of Aadhar No has not been completed in the State due to ongoing updation of NRC, it has been exempted for the State for the time being. However, MHRD, GOI has instructed to seed the bank account with any other valid identity proof of students like pass port, driving licence, PAN Card, etc.

You are, therefore, requested kindly to take urgent necessary action in this regard and seed all the bank accounts of the students for DBT of scholarship.
